The Sandman-Shelifoe claim was set aside. DOC was asked to obtain information from Mr. Greg Davis and contact Mr. Sandman-Shelifoe regarding what he actually wants prior to a future Subcommittee meeting.

Rep. Loeffler requested that a system for numbering claims be developed to better facilitate following claims before the Subcommittee.

Sen. Latz requested that notification of Subcommittee hearings be provided to released prisoners with claims and that the Department of Corrections notify the Claims Subcommittee when prisoners with pending claims are released.

In reference to the Novak claim, Sen. Olseen asked about storage of prisoners' personal property. Michele Timmons, Revisor, indicated this question should be asked of the Department of Human Services, not the DOC.
